3. **HOW TO PARTICIPATE.** Purchase of a Logitech LIGHTSPEED gaming mouse – PRO Wireless, G502 LIGHTSPEED, G903, G703, G603 and G305 ("Qualifying Device") from the Participating Retailers during the Promotion Period as defined below is required to participate in the Offer and claim a complimentary Logitech G240 mouse mat (the "Gift"). Participant may only claim one Gift per Qualifying Device.
